2½ year olds: 2 days	\$200.00		3 year olds: 3 days	\$245.00
2½ year olds: 3 days	\$245.00		4 year olds: 5 day half days	\$320.00
3 year olds: 2 days	\$245.00		4 year olds: 5 full days	\$640.00

Tuition for the entire school year is divided into 10 equal payments, August, 2023 – May, 2024. There is no payment due in June. Tuition is due by the first of each month, starting August 1st. (**Note:** For the 2½ year old class that starts in January, there are 6 payments in total; the tuition down payment is due in December and the remaining 5 payments are due January through May.)

Please Do Not Send Payments In Your Child’s Tote Bag Or Hand ANY Payments To Teaching Staff

- 1. Processing Payments through Brightwheel: \*preferred\*** If you are not already registered with our school- upon registration, you will receive an invitation to join the Brightwheel App. You will then need to set up your billing profile. \*Billing through Brightwheel is completely secure- Hillside staff does not have any access to input or change any parent billing information.

**There are a few ways to pay using our Brightwheel online app:**

- Auto Pay: automatic payments to be processed through your bank account or your credit card.
- One Time Payments: can also be made through your bank account or your credit card.

**Brightwheel Processing Fees:**

\*If you pay with your credit card there is a 2.9% convenience fee per transaction.

\*If you make a payment directly from your bank account, there is a \$0.60 convenience fee per transaction.

- 2. Cash or Check Payments: placed in the black locked mailbox by the Preschool Main Entrance.**
  - Please put your payment in an envelope labeled with your child’s name.
  - Please put your child’s name on the memo line of your check.
  - If you would like a receipt- please bring your payment directly to a member of the administration team during school hours and we can accommodate your request!
- 3. Mail:** You can also mail your payments/paperwork to the school address, listed below.
